INTRODUCTION

1. In accordance with article 32 of the Constitution of The Patrician Society (hereafter referred to as "TPS" or "The Society"), an Annual General Meeting (AGM) was called on 14th Sep 2024 at 2.30 pm at the St Patrick's Heritage Room and via Zoom with clear notice of meeting published on the Society's website and Facebook. Members had also been notified via their email address.

PROCEEDINGS OF THE AGM

2. The AGM was adjourned as the quorum was not met at 2.30 pm. Based on Article 40 of the Constitution, at 3.00pm COL (Ret) Rupert Gwee, the incumbent President of The Patrician Society, declared the numbers present to be a quorum and called the meeting to order. He outlined the AGM's agenda.

ITEM 1 - CONFIRMATION OF MINUTES OF AGM ON 9th SEPTEMBER 2023

3. President stated that the minutes had been previously circulated to those who attended AGM 2023. He asked if there were any amendments to the minutes of AGM 2023. The motion to accept the minutes was proposed by Louis Lim and seconded by Dr Anthony Yee. The motion was unanimously passed by all present.

ITEM 2 - PRESIDENT'S ANNUAL REPORT JUL 2023 - JUN 2024

- 4. **Opening Remarks.** President shared that the past year have been very busy and as has become his practice, he gave a presentation of the past year's main events and activities.
- 5. **Membership Update**. President updated that membership to date stands as follow: 388 x Life members; 5 x 10 years Ordinary members, 3 x Ordinary memberships and 5 x Junior members.

6. Major Activities/ Events.

- a. <u>Teacher's Day 2023</u>. The Tea with Former Teachers/ Staff 2023 was held immediately after last year's AGM. 22 former teachers/ staff attended the event.
- b. <u>Graduation of Sec 4 & Sec 5 students</u>. The graduation ceremony was held on 29th Sep 2023. President shared that the Society presented a custom ordered "**Sons of St. Patrick's Valiant and True**" collar badge to the graduating cohort. For this year's graduating cohort, the School will purchase and present each student with the special 90th Anniversary 6-badges presentation set.
- c. <u>Christmas Eve Mass and Reception</u>. It was very well attended even without any publicity and by just word of mouth. Father Valerian was the celebrant. The Patrician Society sponsored a reception after the Mass.
- d. <u>90th Anniversary Dinner</u>. This was held at Orchard Hotel Grand Ballroom on 29th Dec 2023. The Guest of Honour was Mr. Patrick Tay, Asst Gen-Sec NTUC & MP for Pioneer. The event became the talk of the town and the spontaneous performances by Dorthy Sng, a current teacher and some old boys set new standards for entertainment. The School generously declined any of the \$4,000+ surplus and instead transferred it to the Society.
- e. <u>St. Patrick's Day Parade 2024</u>. This was held on Sunday 17th Mar 2024. President shared that as the Singapore Police has banned the

display of any flags for such parades, St. Patrick's School which traditionally provided the colour-escort has been relegated to forming the 3rd contingent. Mr Ong Ye Kung attended as the parade's Grand Marshall.

- f. Combined Founder's Day Dinner 2024 and St. Anthony's 145th

 Anniversary Dinner. This evolved into a combined event organised by St. Stephen's Old Boys Association (SSOBA) and Anthonian Alumni (AA), St. Anthony's primary School alumni association_and was held at Farrer One Hotel on 30 Apr 2024.
- 7. **Forecast of FY 2024/ 2025 Events**. This is as follows:
 - a. 24th Aug 2024 Alumni Homecoming Lunch 2024 completed.
 - 1) This was held at the Heritage Room and was attended by 90 persons including 22 former teachers. The upgraded format replaces the annual Tea with Former Teachers. Up 120 pax may attend but priority will be given to former students marking their, 10th, 25th, 30th, 40th and 50th anniversary graduation from St. Patrick's School. The School Principal gave a presentation of the School's recent sterling academic results (best "O" Levels result in 10 years and best "N" Level in 5 years!) and shared how this was achieved through the School's holistic boy's-centric education.
 - 2) President shared that Mr. Chan Chun Sing, Minister for Education visited the School twice last year and noted how the School had transformed! The School Management Committee will fund this annual event as a strategic investment and as part of the run-up to the School's 100th Anniversary. President was heartened that coincidentally, the School had hosted a couple who made a generous donation of over \$50K just before the event.
 - b. <u>24th Dec 2024 Christmas Eve Mass</u>. This annual event will continue to be supported by The Patrician Society and we will hold a small post-Mass reception.
 - c. <u>16th Mar 2025 St. Patrick's Parade</u>. This will likely be held on Sunday 16th Mar 2025 as actual St. Patrick's Day 2025 is on Mon 17th Mar 2025. Hopefully, we will have earlier notice of confirmation from the organisers.

ITEM 3 - FINANCIAL STATEMENTS FOR PERIOD JUL 2023 TO JUNE 2024

8. President showed Balance Sheet of The Patrician Society at 30 Jun 2024.

The **bank balance** stood at **\$15,939.74** and if we include memorabilia stocks, the Society has **total worth of \$33,744.32**. The accounts have been checked by our honorary auditors, namely Mr. Francis Paulus and Mr. Francis Thompson.

9. As at 11th Sep 2024, the Society's bank balance stood at **\$22,585.74** as the school had purchased 266 sets of 90th Anniversary Commemorative 6-badges presentation sets for this year's graduating cohort mentioned earlier. President highlighted that The Society has been steadily growing it finances over the year from the meagre \$2K plus in 2015.



Badges and Symbol of St. Patrick's School (1933 – 2033)



The first badge of the school had no motto but the shield is beautifully designed with the Shamrock and the Lasallian Star with the wavy lines depicting the sea behind the School.



The second badge came into use in the postwar period. It was Brother Alban who came up with the school motto; and the general shape was based on the architectural motif over the field-side portico of the school.



The third badge came in the sixties and included the SPS monogram. It was designed by Brother Arnold and is the first badge which displays the Lasallian Star prominently in vellow.



The fourth and current badge was designed and introduced by Brother Joseph McNally in the seventies. He restored the Lasallian Star and Shamrock to their original positions.



The fifth badge was unveiled in 2022. The arrangement preserves cherished school symbols, set within a refreshed colour scheme. It reflects the school's commitment to building on its rich history even as it takes on the future with renewed zest.



The symbol of the school which says so much in simple form was designed by a former pupil and teacher, Mr Patrick Ang in 1975. The Shamrock is well known as the symbol of St. Patrick, the patron saint of Ireland.
